### APPLICATION FOR ADMISSION TO RESIDENTIAL HALLS AND RESIDENTIAL COLLEGES 2025-2026 (for Current Full-time Undergraduate Students)

#### Round II

#### General Information and Instructions

Current full-time undergraduate students who have no prior hall experience in the academic year 2024-2025 and wish to apply for admission to residential halls and Residential Colleges in Jockey Club Student Village III and Jockey Club Student Village IV (Wong Chuk Hang) in 2025-2026 should submit your application via HKU Portal, the University's on-line information system. Students should read the following instructions carefully. Applicants should note that it is their responsibility to follow the application procedures and to note the important dates of the admissions exercise detailed below. Failure to follow the application procedures and to respond promptly to calls for interview or offers of admission may lead to applications being rejected and offers being withdrawn.

**[IMPORTANT:** Current students who have been de-registered will not be able to access the HKU Portal. If you have been de-registered due to outstanding fees, please note that it will normally take one to two working days for the Finance and Enterprises Office (FEO) to settle your payment (clearance and approval). When your payment is cleared and approved by the FEO, your student status will be re-instated in an hour automatically. Please therefore ensure that you do not have any outstanding fees during the application period and reserve ample time before the application deadline for re-instatement of student status, if necessary. #### Reference Documents

1. A summary of the key arrangements for hall admission can be found in document 153/624 ([Appendix A](#)).
2. A new hall admission scheme, approved by the Senate, has been implemented with effect from 2009-2010. The gist, including the eight principles of hall places allocation and the formula of arriving at an admission score for each applicant (comprising a need score (N) and a merit score (M)), is summarized in document 113/409 amended ([Appendix B](#)).
3. More details on the need score (N) system for 2025-2026 are provided in document 81/425 ([Appendix C](#)) while details on the admission criteria, viz. the calculation of the merit score (M), for the respective residential halls can be found in document 62/424 ([Appendix D](#)).
4. A brief information sheet on the halls can be found in document 83/425 ([Appendix E](#)).

#### How to Apply

5. To start the on-line application, you have to launch the web browser (Internet Explorer 5.5 or above is recommended). Then you can access on-line application system via
  - a. the HKU Portal (<https://hkuportal.hku.hk>)
  - b. → Login HKU Portal<sup>1</sup> → select "SIS Menu" → select "On-line application" → select "Application for Resident Hall" and the appropriate application form according to your current personal particulars and intended status in the coming academic year will be displayed.

The on-line application system may not be available during the IT Service's maintenance period (2:00 a.m. – 6:00 a.m.) or other scheduled periods.

6. Please complete the form in [English](#), unless otherwise specified.
7. If you are preparing your application with a word processor, please use Notepad or Wordpad. Please make sure the information saved can be displayed correctly if you are preparing your application with Microsoft Word.

8. During the application period, you can return to your saved application form to make amendment or cancel an application before you finalize and submit the application.
9. In order for your application to be considered by halls/colleges, you must “Preview Draft” and “Submit & Finalize” it within the application period. Once an application is finalized, no changes can be made. For any enquiries during application, please contact Mr. Thomas Yang of the Academic Support and Examinations Section at 3917 7082.

### **Closing Date and Submission of Application**

10. The on-line application system will start at **10:00 a.m. on Friday, August 8, 2025.** Finalized application should be submitted on-line no later than

*5:59 p.m., Thursday, August 14, 2025*

Late applications will **NOT** be accepted, except those from applicants who receive an admission offer from the University on or after the closing date stated above. Successful applicants will be notified individually by the halls/colleges.

11. You are strongly advised to apply as early as possible within the application period during August 8-14, 2025 in order to avoid system overload near the application deadline which might result in delay in submission or even rejection of your application.

### **Interview**

12. Applicants may be required to attend a selection interview during the following period:

*August 8 (Friday) – August 17 (Sunday), 2025*

13. The halls/colleges will directly contact applicants for selection interviews. Applicants could check directly with the hall/college concerned for further details.
14. It is important that you try your best to make yourself available for the selection interview. Failure to attend the selection interview will imply that you are no longer interested in the application. If you have any special difficulty in attending the selection interview at the scheduled time, you should contact the hall/college concerned in advance.

### **Announcement of Results**

15. Applicants can visit the Centre of Development and Resources for Students' Website (CEDARS) at <https://cedars.hku.hk> for information on hall application results.
16. After the announcement of results at 4:00 p.m. on August 18, 2025, an applicant who is offered a place must indicate acceptance of the offer through the on-line system of the HKU Portal (<https://hkuportal.hku.hk>) → Login HKU Portal<sup>1</sup> → select “SIS Menu” → select “On-line application” → select “Application for Resident Hall” → select “Application Status” by 5:00 p.m. on August 19, 2025. The offer of admission will be automatically withdrawn if a student fails to do so.

### **Appeal**

17. Unsuccessful applicants who wish to appeal against the decision of halls/colleges should submit their appeals through the on-line system of the HKU Portal (<https://hkuportal.hku.hk>) → Login HKU Portal<sup>1</sup> → select “SIS Menu” → select “On-line application” → select “Application for Resident Hall” → select “Request for Appeal” within 72 hours immediately following the announcement of the results.
18. Applicants shall be informed of the result of the appeal by the Wardens concerned.

### **Non-Acceptance of Admission Offer**

19. An applicant who has turned down an offer of residential membership from a hall/college stands the chance of not being assigned any residential place in the same year.

## Hall Charges

20. The hall charges for residential halls for 2025-2026 are as follows:

23. The lodging charge for Jockey Club Student Village IV (Wong Chuk Hang) for 2025-2026 is HK\$48,776.00.

### Committee on Halls

#### Summary of Key Arrangements for Hall Admission

The Senate approved guidelines for the selection of candidates for admission to halls of residence in May 1975. These guidelines were modified in March 1982, July 1989, March 1992 and again in December 1999. Further changes have been made according to the recommendation of the Hall Review in 2017 and Hall Reform in 2022. The following is a summary of the key points of the system.

#### I. Readmission Panel

The Senior Management Team believes that the wardens, as leaders appointed by the University, should play a larger role in constituting the hall community. It further believes that colleagues in the Housing Team of the Centre of Development and Resources for Students (CEDARS) should offer expert advice and support to the wardens in undertaking that role, and at the same time generate greater consistency across the entire hall community. In light of the above, the readmission panel has been reconstituted as follows: a warden and a tutor (to represent hall management), two SA members (to represent hall residents) and two CEDARS staff (to represent the University).

(C.O.H. 11.2.2022 and C.S.A. 18.2.2022)

#### II. Residential Hall Admission Advisory Group (RHAAG)

**The Warden** may take advice from a Residential Hall Admission Advisory Group (RHAAG) comprising both staff and students. **The final decision is made by the Warden alone.** The RHAAG shall comprise two tutorial staff appointed by the Warden and two student members of the Hall appointed by the Hall Students' Association. The Warden may attend but not vote in the meetings.

#### III. Hall Admission: Appeal and Monitoring System

In December 1999, in response to the call for more transparency in hall admission and the need to tackle problems arising from hall orientation, a Working Group on Hall Orientation and Admissions was set up by the Committee on Student Affairs to (a) review the administrative aspects of hall orientation programmes and (b) review and formulate an appeal and monitoring system relating to hall orientation and admissions. (C.S.A. 17.12.1999)

“c) Appeal System

Handling of appeal cases should be as follows:

- i) for reviewing appeal cases, Wardens should, as far as possible, be personally involved, in addition to receiving feedback from resident tutors, floor Chairman and hall associations etc.;
- ii) Wardens should interview residents making appeals together with the Appeal Panel, and write to those residents whose appeals were unsuccessful with specific reason(s) for rejecting their appeals in a formal letter; and that the Wardens should aim to interview students with the Appeal Panel and send out the letters normally within one calendar week;
- iii) students' appeal letters and wardens' letters should be copied to the Dean of Student Affairs;
- iv) to ensure objectivity and fairness, the Appeal Panel should be composed of members different from those in the residential hall Admissions Advisory Committee;
- v) the Appeal Panel should comprise three members: Warden from another residential hall (external member), at least one senior hall tutor / hall tutor (internal member) and at least one student representative (internal member);
- vi) students should be told clearly how the panel is formed;
- vii) members of the panel should be made known to students before re-admissions i.e. in April; and
- viii) **Wardens make and are ultimately responsible for all admission and panel decisions as the Admissions Advisory Committee and Appeal Panel are only to assist them in arriving at their decisions.**

(C.S.A. 24.3.2000, 3.4.2000, 30.4.2021 and C.O.H. 25.11.2021)

IV. Duration of Residence

**Admission on each occasion is for one year only. Residents may be re-admitted in subsequent years on the basis of the criteria for re-admission and such is not automatic. From the academic year of 2024-25, residents whose residential years are equal to or exceed the normative study period minus one year (P-1) will be given the lowest priority when they apply for residency. Exceptions for special circumstances will be considered on a case-by-case basis, with the recommendations from the Warden and endorsement from the Chairman and Vice-chairman of the Committee on Halls. (C.O.H. 18.4.2024)**

Because of disciplinary offence, the Warden may “terminate, upon giving one week’s notice, a membership of the Hall, in which case the student may request the Committee of the Hall Association to request the Warden to communicate to them all the circumstances relating to the termination of hall membership.” (H9 of Regulations Governing Halls).

V. Grievances Procedures

Procedures for dealing with student grievances arising from hall admissions are also established accordingly:

- a) While appeals for Hall Admission results should be addressed in the first instance to the Wardens of the respective halls, students who have grievances arising from Hall Admissions may seek assistance from the Dean of Student Affairs.
- b) If the grievances cannot be resolved at the Warden's level and the Dean's level, the student may submit his/her grievances in writing to the Vice-Chancellor.

### Committee on Halls

#### New Hall Admission Scheme

1. The Committee on Halls set up a Task Force on Hall Admission Quotas to undertake a widespread consultation with relevant stakeholders with the brief to “develop a new admission scheme”. The Task Force undertook its work from March 2007 to May 2008 with its Final Report endorsed by the Committee on Halls (CoH) on June 25, 2008 and the Committee on Student Affairs (CSA) on September 26, 2008.
2. During its investigation and consultation across the University and in formulating its recommendations for a new system to distribute admission quotas for residential halls, the Task Force has taken into consideration a number of issues of concerns including the balance between hall education and the absolute need of the students, the need for a uniform admission policy for all student halls while maintaining a certain degree of flexibility, the accommodation of non-local students in halls, the need to increase the transparency of the procedure and criteria of hall admission, re-admission and appeal system, etc.
3. The Final Report of the Task Force on Hall Admission Quotas was discussed by the Senate at its meeting on November 4, 2008. The Senate agreed to adopt a new hall admission scheme with effect from the academic year 2009-2010, with the principles of allocation and operational guidelines detailed in the Final Report.
4. The principles of allocation govern the basic rationale of the system which is to be realized through the “operational guidelines”. The operational guidelines are more flexible and may be changed by the Committee on Student Affairs upon recommendation from the Committee on Halls.
5. Principles of allocation
  - (1) The relative importance of need (N) and merit (M) factors in the consideration of hall admission should be reflected by the relative weightings (n and m respectively) assigned to these two types of factors rather than quotas.
  - (2) Define absolute need for local undergraduate students. Local undergraduate students with absolute need and nonlocal undergraduate students are guaranteed one year of hall residence.
  - (3) The same weightings (m and n in Principle 1) will be applied to all undergraduate students after one year of hall experience except those specified in Principle 5 below.
  - (4) Non-freshman undergraduate students who do not have any hall experience should have a reasonable chance of successfully applying for a hall place.
  - (5) Halls set aside a small percentage of places for undergraduate students without taking into consideration of the need factors and another small

percentage of places for undergraduate students with proven special physical or psychological needs.

- (6) The overall percentage of non-local undergraduate students in all residential halls taken together should be capped at a figure to be reviewed when new halls are built or when there is a major change in the University's policy of admitting non-local students. Currently, the overall percentage of non-local students in all residential halls is about 30%.
- (7) There should be a small percentage of postgraduate students in undergraduate halls.
- (8) There should be a high degree of transparency and accountability in the hall admission (including re-admission) system (including both the criteria and procedures).

## 6. Operational guidelines

### Principle (1)

*The relative importance of need (N) and merit (M) factors in the consideration of hall admission should be reflected by the relative weightings (n, m) assigned to these two types of factors rather than quotas.*

- a) Each hall applicant is assigned an admission score according to the following formula:  
Admission Score =  $n * N + m * M$   
(N: need score 0 -100, M: merit score 0 – 100;  
m,n: weightings, 0 – 1)
- b) The need score includes travel time, usable area per person at home and type of housing. It will be computed using a scheme similar to the existing formula for the Joint-Hall Admission Scheme. However, there is new category of “absolute need” students (Please see point (d) below).
- c) Each individual hall may decide how the merit score is computed but the calculation must be widely publicized. For students with no prior hall experience (including new HKU entrants), the merit score takes into consideration of academic and non-academic achievements, expected contribution to hall life, match with the style of the hall, and performance interview. For students with prior hall experience, additional criteria will be considered: observation of hall rules, responsible and respectful behavior, and other factors the hall may deem fit.
- d) The Committee on Halls further agreed at its meeting held on April 3, 2009 that students who were admitted into the halls on or after February 1 of the academic year concerned would be considered as “students with no prior hall experience”.

Principle (2)

*Define absolute need for local undergraduate students. Local undergraduate students with absolute need and nonlocal undergraduate students are guaranteed one year of hall residence.*

- e) Local students who need to travel more than 3 hours per day are considered to have “absolute need”. Their need score is 100.

Principle (3)

*The same weightings (m and n in Principle 1) will be applied to all undergraduate students after one year of hall experience except those specified in Principle 5 below.*

- f) As senior students have more knowledge about Hong Kong which puts them in a better position in finding their own accommodation in the community, the relative weighting of need, n in the equation, should diminish as the student progresses. The following tables shows the relative weightings over the study period of various types of students:

<sup>2</sup> Principle 5 effectively specifies two small percentages for assigning m = 1 & n = 0, and m = 0 & n = 1 to small percentages of students.

Principles (4) and (6)

*Non-freshman undergraduate students who do not have any hall experience should have a fair chance of successfully applying for a hall place.*

*The overall percentage of non-local undergraduate students in all residential halls taken together should be capped at a figure to be reviewed when new halls are built or when there is a major change in the University's policy of admitting non-local students. Currently, the overall percentage of non-local students in all residential halls is about 30%. [see Note below]*

- g) Each hall may decide to assign 1/3 to 2/3 of its intake of students with 0 year of hall experience at the beginning of each academic year to nonlocal students (with ‘n’ equal to 1) depending on its circumstances, with the constraint that the overall percentage of nonlocal students in halls at 30%-33%, and the overall percentage of students with ‘n’ equal to 1 in the intake of each year across all halls at 70%. If the number of local students with ‘n’ equal to 1 exceeds the number of places for them, then admission of such students would be decided by lottery. Students who do not get a hall place in the lottery will be considered in the m = 0.5, n = 0.5 category with the need score (N) kept at 100.

*[Note: In light of the quota for nonlocal undergraduate admission is being increased to 40% of the student population in 2025-2026, the Committee on Halls at its meeting on June 16, 2025 endorsed a proposal from CEDARS that the quota of hall places for nonlocal students be adjusted to 43% in 2025-26.]*

#### Principle 5

*Halls set aside a small percentage of places for undergraduate students without taking into consideration of the need factors and another small percentage of places for undergraduate students with proven special physical or psychological needs.*

- h) Halls set aside 3% of places for undergraduate students without taking into consideration of the need factors and 3% of places for undergraduate students with proven special physical or psychological needs.

#### Principle 7

*There should be a small percentage of postgraduate students in undergraduate halls.*

- i) The minimum quota for postgraduate students in undergraduate halls should be kept at 2%.
- j) Selection of postgraduate students in undergraduate halls should be performed by halls.

#### Principle 8

*There should be a high degree of transparency and accountability in the hall admission (including re-admission) system (including both the criteria and procedures).*

- k) The following accountability measures should be implemented in the hall admission system:
  - i. All admission/re-admission interviews must be conducted in the presence of a tutor/senior tutor/warden.
  - ii. There should be one to three current residents (e.g., members of the executive committee of the hall association) in each admission or re-admission interview.
  - iii. All appeals must be considered by the warden.
  - iv. A written letter should be issued by the warden to every unsuccessful appeal applicant to state the reasons of rejection, copied to the Committee on Halls or the Dean of Student Affairs.
  - v. Halls should submit their admission and re-admission criteria and procedures, including those of the floors, to the Committee on Halls for endorsement; and widely publicize them.
  - vi. Upon request by an applicant, halls must provide him/her with his/her personal information used in the admission/re-admission.
  - vii. Students should provide proof of residential status/travelling time, achievement etc. at the interview.

#### **Hall Admission Criteria in arriving at the Merit Score (M)**

1. Halls are part of the education system of the University rather than just a provision of accommodation. They are a very effective vehicle to integrate students' social and intellectual lives, and therefore represent a golden opportunity for the full development of students.
2. Hall members are expected to learn to be independent and interact closely with students of various backgrounds in their halls. They are also expected to take full advantage of such a precious opportunity to actively participate in various hall activities so as to develop their personal abilities (e.g. leadership skills), personality, communication and social skills, as well as intellectual ability.
3. Hall members are expected to identify strongly with and shoulder civic responsibilities in their hall. Through developing such a sense of belonging and commitment to the hall, members will also develop a similar sense of commitment to the society.
4. For students with no prior hall experience (including new HKU entrants), the merit score takes into consideration of academic and non-academic achievements, expected contribution to hall life, match with the style of the hall, and performance interview. For students with prior hall experience, additional criteria will be considered: observation of hall rules, responsible and respectful behavior, and other factors the hall may deem fit.

#### **Round I: Re-admission Exercise in April**

5. For the re-admission exercise in April, the merit score will be calculated on the basis of 50% participation in hall activities (with campus and community participation bonus) and 50% academic performance (with Semester GPA bonus).
6. Each individual hall may decide how the hall participation component of the merit score is computed but the calculation must be widely publicized. The respective criteria of individual halls as to how the hall participation component of the merit score will be computed can be found in the Annex to this document. Each individual hall should also elaborate in the Annex the criteria of gaining bonus score through campus and community participation.

7. On the academic performance component of the merit score, it will be calculated based on applicants' Cumulative Grade Point Average (CGPA). To be considered for re-admission, applicants must obtain a CGPA of 2.0 or above and the score will be computed based on the table below:

8. In order to recognize students' effort in achieving improvement in academic performance, the admission panel may adjust the score upward by one or two categories for applicants with a Semester GPA higher than his/her CGPA.
9. For applicants enrolled in programmes without a GPA system, the academic performance component of the merit score will be awarded on a scale of 1 to 10 based on the academic ranking provided by respective programme.

**Round II: Admission Exercise**

10. Each individual hall may decide how the admission score is computed but the calculation must be widely publicized. The respective criteria of individual halls as to how the admission score will be computed can be found in the Annex to this document.

Hall members of Lady Ho Tung Hall are strongly encouraged to participate more and show leadership in hall functions in order to achieve what Lady Ho Tung Hall has always cherished – Unity, Striving for the Best and being Tough and Strong. Hall mates are encouraged to try more things in order to develop various abilities such as leadership skills, time management, communication skills, and more importantly, to build up a sense of belonging to Lady Ho Tung Hall which has a long and profound history.

Merits will be given to each student in the re-admission process based on the following factors:

- Leadership in various capacities e.g. Students' Association, Summer Organising Committees, Team Captains, Floor Representatives, Function-based or Activity-based Sub-committee PIC.
- Have been a responsible Organizing Committee member of Orientation Camp, Feel Camp and Registration Day
- Good attendance, participation and attitude in teams, sub-committees and interest groups
- Good attendance, participation and attitude in hall and floor functions
- Have been co-operative and considerate
- Have shown enthusiasm and are able to communicate well with others
- Have observed hall rules and regulations

Marks will be deducted for absence from compulsory functions and disciplinary action subject to consequences.

Participation and Leadership outside hall (up to 10% additionally)

Being a member of U-teams\* and at the same time a member of the corresponding hall teams or an Executive Committee member of different associations under the Hong Kong University (HKU) will be merited.

\* U-teams include 11 sports teams (Aquatics Team, Athletics Team, Badminton Team, Basketball Team, Handball Team, Hockey Team, Softball Team, Squash Team, Table Tennis Team, Tennis Team, and Volleyball Team) and 3 cultural teams (Bridge Team, Debate Team and Union Choir)

Students will also be awarded for participation in community services organised by CEDARS and the Hall.

### **Remarks**

Hallmates will be ranked according to their merit scores. A cut-off will be applied based on the readmission rate mandated by CEDARS. All hallmates below the cut-off will not be admitted. Borderline cases will be invited for an interview.

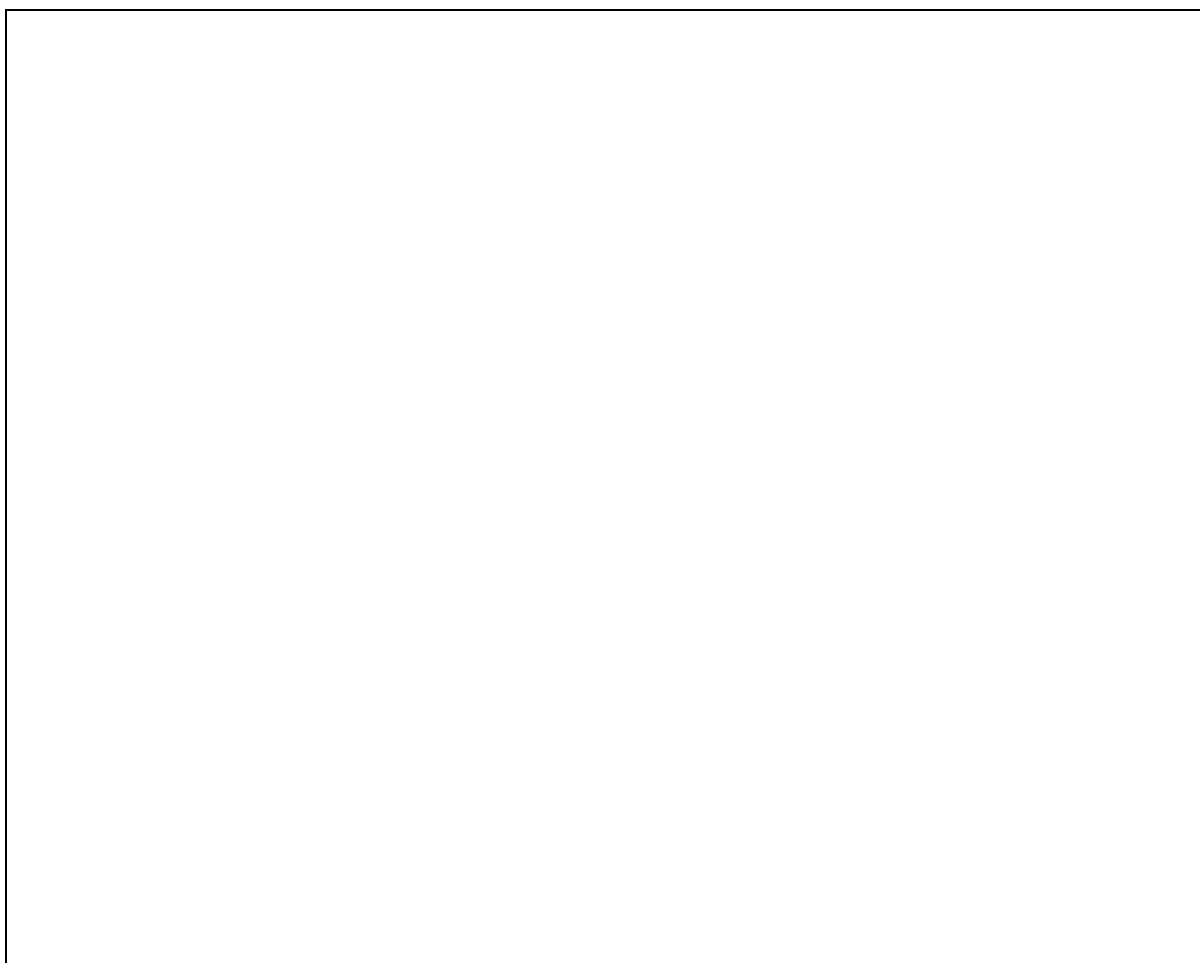

  - 3.4 C4 - marks deducted based on their disciplinary records in the latest residential year.
  - 3.5 All current RCLHSA office bearers, namely, Executive Committee members, Editor-in-chief and Assistant Editors-in-Chief of Editorial Board, Director-in-Chief and Assistant Directors-in-Chief of RCTV and Chairperson of the Representative Board, automatically receive full marks in categories C2 and C3.
4. C4 scores will be deducted as follows:
  - 4.1 5 marks will be deducted for each absence from High Table without approval;
  - 4.2 Absence from High Table due to clashes with course lectures (and lectures only) are exempt from all deductions if prior approval is sought from the warden.
5. C1 scores will be awarded independently by the tutorial team as a single unit to an applicant based on his/her overall performance over the year past in the following areas: passion and vision in hall life, leadership, social awareness, civic responsibility, and achievement in various aspects both inside and outside the hall community. Among the 25 marks, 9 marks are reserved as bonus available to hall residents who demonstrate meaningful participation in non-hall activities on campus or in the wider community.
6. C2 and C3 scores will be awarded by the respective student groups. The functional groups responsible for awarding these scores will determine their own systems to reflect residents' merits and contribution in the respective areas.
7. Scores may be revised after interviews, as deemed appropriate. The C1 score shall be revised by the tutorial team. C2 and C3 scores shall be revised by the RCLHSA Executive Committee.

This part constitutes the comments and ratings from the floor mates, in terms of a hall mate's contribution on his/her residing floor and relationship with other floor mates.
- c. Tutors' Evaluation (Maximum 10 marks)  
This component involves an individual interview between a designated tutor and the hall mate. The overall hall experience of the hall mate will be discussed and rated. Different aspects of hall mates' development would be considered, academic performance, performance on the floor, perceived hall education, external contributions, balance between different aspects of life, special personal needs etc.

Extra bonuses will be awarded to the admission score (A) of 100 marks for the aspect listed below.

- a. Bonus for Non-Hall Activities (10% bonus)  
10% bonus available to hall residents able to demonstrate meaningful participation in non-hall activities on campus or in the wider community.
- b. Bonus for Cultural and Sports Talent (Half of the maximum mark of the corresponding hall team)  
In order to reward talented hall mates who have devoted their effort in the hall teams, hall mates who have good performance in any of the hall teams, and at the same time are members of the corresponding university team will be awarded a bonus of half of the maximum mark of the corresponding hall team.

The admission score (A) of 100 marks will be deducted for the aspects listed below.

- Penalty for High Table Dinner (1 mark for each regulation violation (except absence), 6 marks for absence, NO maximum penalty is set in this aspect)

The list of hall events should be compiled before the Round 1 Application period. Organizers of the events should provide the helper list and participant list to the admission panel for point calculation before the deadline of Round 1 application. #### **(b) Team score**

The sports team captains and persons-in-charge of cultural groups will evaluate the participation and contribution of the team members. Factors to be considered include: regular attendance at training/practice sessions, enthusiasm, leadership. Team captains and persons-in-charge (PIC) will be evaluated by the SA Chairperson in consultation with the current and immediate past SA Executive Committee.

The performance score should be summed up with all teams the student participated, based on the following criteria:

**St. John's College**

St. John's College will not take the "Need Score" (the so-called "N Score") as the main factor for consideration.

St. John's College is administering its own admission and has its own criteria; although St. John's College is accepting applications for admission through the on-line hall application system.

As regards our admission criteria, St. John's College is looking for students who have a good potential, and a passion, to excel in academic studies, sports, cultural activities, leadership development, and/or community service. For years, St. John's Alumni had become prominent leaders of our community. Assessment for admission to is mainly by interview. The Master of the College has the final say in admission. In making his decisions, the Master may consult the Dean of the College and student representatives.

In recent years, St. John's College is very concern with the academic performances of our students. Starting 2008, we introduced academic tutors into the College, who would see students personally and regularly to help with their studies.

St. John's College started as the first hall of residence in HKU in 1912. The College aims to provide the best all-round education to HKU students. We strive providing the best facilities. We have a spacious campus, an exclusive dining hall, and we provide only single rooms. We are constantly seeking methods to enable students to best develop themselves in a congenial environment. And we have a policy to consider seriously the re-admission of students recurrently after their first year of residence in the College.

Last but not the least, most St. John's alumni may tell you this: they had met the best friends of their lives in St. John's.

## THE UNIVERSITY OF HONG KONG

**Student Residences 2025-2026**

There are at present 21 student residences in the University. Among these student residences, 11 are University-administered Halls of Residences and 8 Residential Colleges: Lady Ho Tung Hall, Lee Hysan Hall, Lee Shau Kee Hall, Morrison Hall, R.C. Lee Hall, Simon K.Y. Lee Hall, Starr Hall, Suen Chi Sun Hall, Swire Hall, University Hall and Wei Lun Hall; Residential Colleges on Lung Wah Street and Wong Chuk Hang. Two Halls of Residences, Ricci Hall and St. John's College, are managed directly by outside religious bodies.
